

TRAINING

OBJECTIVES

The aim of this course is to train the trainer: He/she has full and complete responsibility for the activity of "preparing and running training courses" and may have specific duties such as:

- referent for a training product or course,
- referent or coach for one or more people for the duration of their training or professionalisation contract,
- co-coordinator of a teaching team (without being hierarchical).
