


TRAINING

OBJECTIVES

Acquire the qualification and skills for the reception, care and maintenance of the living environment of children under 6 years of age, in nursery schools/collective care centres for minors, at the parents' home or at their own home, in collective care establishments/services:

- conduct activities to animate and awaken young children with the aim of learning the rules of collective life, helping them to acquire autonomy, and aiding their emotional, intellectual and sensory development.
- carry out daily care activities (care, bodily hygiene, help with meals) in line with the child's physiological, emotional and physical safety needs.
- carry out sanitary maintenance activities.
- establish a relationship of trust with children and parents.

This diploma enables you to sit the eligibility tests for the auxiliary nursery nurse training course as well as the ATSEM competition organised by local authorities.







PROGRAMME

The training is structured around Competency Blocks (CB):

BC01 - Accompanying the development of the young child

- Gathering information, and the professional situation to be taken into account
- Adopt an appropriate professional stance
- Implement conditions conducive to free activity and experimentation in a given context
- Maintain an appropriate professional stance
- given context
- Implement early-learning activities, taking into account the child's individuality
 Perform daily care and support the child in his/her learning

- Apply protocols related to the child's health
 BC02 -. Carrying out your activity in group childcare
 Cooperating with all the players involved with the aim of coherence, Working in individual childcare
- . Organising activities
- . Negotiating childcare arrangements . Assisting with the upkeep of the child's accommodation and areas
- Preparing meals

BC04 - French and history-geography-moral and civic education BC05 - Mathematics and physics-chemistry

BC06 - Physical education and sport

BC07 - Prévention-health-environment

NB: General education modules may be waived under certain conditions.
