## TRAINING

### OBJECTIVES

Holders of the BTS in Operational Security Management carry out their duties in the field of security and safety. They carry out their activities either in a security/safety company or in the internal security department of an organisation (company, public and private administration, association).

The main objectives of the course are to equip the professional with the skills needed to organise safety and security activities in order to:

- manage teams
- participate in the administrative and legal management of personnel
- manage customer relations in conjunction with his/her hierarchy
- liaise with the various institutional players and participate in security bodies
